GRITS FESTIVAL TERMS AND CONDITIONS

- 1. Electrical Information:** 120V/20 AMP Electrical service will be provided for each booth if requested.

(Vendors are responsible to provide own heavy-duty extension cords and necessary adapters)

- 2. Vehicles Information:**

After unloading of your needed equipment and supplies you are required to move your vehicle to the parking area designated for vendors.

- 3. Access to Grounds:**

Concessionaires will be granted access to event grounds beginning at 2:00 pm on Friday, May 4th and/or 7:00 am Saturday, May 5th. All vehicles must be off event site by 8:30 am Saturday, May 5th. Mill or Festival Committee not responsible for anything left on Mill property Friday night.

- 4. Breakdown and Clean-up:**

Cleaning of your equipment must be done off site. All garbage is to be taken to designated dumpsters throughout the event to prevent build-up. Vendor is responsible to supply adequate plastic containers and plastic trash bags for the interior of your booth. Vendor is fully responsible for the clean-up of their specified area. Vendor, by signing this contract, agrees to pay a fine of \$25.00 to Kymulga Grist Mill if they are found to have left any trash or other similar disposable materials on the grounds following event clean-up period. Grits Festival clean-up must be completed by 8:00 pm on May 5th.
